# 1 Purpose of Report

The purpose of this report is to request that Council suspend Standing Orders in so far as they relate to the remit of the Education Appointment Committee and authorise the Chief Executive, in consultation with the Leader of the Council and the Director, Education, Communities and Economy to approve the decision of the Education Appointment Committee, scheduled to be held on Thursday 28 June 2018 to consider the appointment to the Post of Head Teacher, Sacred Heart R.C. Primary School.

# 2 Background

The Scheme of Administration with regard to the Education Appointments Committee, as appended to Standing Orders states:

"The Minutes of the Committee will be submitted to the next meeting of The Cabinet. Persons recommended for appointment by the Committee shall be appointed by the Cabinet, unless it appears to them that the candidate is not eligible for the post, in which case they may refuse to appoint them. Where the Cabinet refuse to appoint a recommended candidate and it is still intended to fill the post, then the post will be re-advertised and the necessary procedures followed afresh.

However, the next scheduled meeting of the Cabinet is not due to be held until Tuesday 4 September 2018 and there is a need to formally approve these appointments as soon as practicably possible.

It is therefore requested that under these circumstances, Council suspend Standing Orders in so far as they relate to the remit of the Education Appointment Committee above and authorise the Chief Executive, in consultation with the Leader of the Council and the Director, Education, Communities and Economy to approve the decision of the Education Appointment Committee, scheduled to be held on Thursday 28 June 2018 to consider the appointment to the Post of Head Teacher, Sacred Heart R.C. Primary School.
