

# Inspection of Lasswade High School Centre

### Report by Mary Smith, Director, Education, Communities and Economy

# 1 Purpose of Report

This report outlines the outcome of the above inspection as carried out by Education Scotland in January 2014.

# 2 Background

- 2.1 Lasswade High School Centre was inspected in January 2013 and their visit in January 2014 was to assess the extent to which the school was continuing to improve the quality of its work, and to evaluate progress made in responding to the main points for action in the initial report.
- **2.2** The Inspectors concluded that the school has successfully made improvements in its approaches to self-evaluation and that leadership across the school was improving.
- 2.3 Education Scotland's Area Lead Officer will discuss with officers in Education, Communities and Economy how best to provide further support to the school and will maintain contact to monitor progress. The Council will provide Education Scotland with a progress report within one year at which point they will decide whether a further inspection is required.

# 3 Report Implications

### 3.1 Resource

There are no financial and human resource implications associated with this report.

### 3.2 Risk

Education Scotland visits a sample of primary and secondary schools every year to find out how they are performing. A report is published which informs parents about the key strengths of the school, its capacity for further improvement and sets out the main points for action.

Following the publication of that report further support will be given to the school by Education Scotland and by the Education Authority to assist improvement and monitor progress. A follow-through report on the progress of the school will published by either Education Scotland or by the Education Authority, within 1 year of the date of publication of the original report.

Monitoring/

Monitoring, review and evaluation of progress by the Schools Group Manager and members of the 3-18 Improvement Team is the control measure in place to reduce the risk of failure of the school to demonstrate its capacity to improve.

# 3.4 Key Priorities within the Single Midlothian Plan

The work of the school supports a number of outcomes within the Single Midlothian Plan including ensuring that young people are better educated, more skilled, successful learners, confident individuals, effective contributors and responsible citizens.

### 3.5 Impact on Performance and Outcomes

The school is continuing to improve its approaches to recognising young people's broader achievements. As a result, more young people are now receiving formal accreditation for their achievements. The school has introduced a new system for monitoring young people's progress in their learning across all subjects. With these and other measures it is expected that the school will continue to ensure a positive impact on the outcomes of young people.

### 3.5 Adopting a Preventative Approach

The school is building on positive initiatives to ensure that the learning needs of all young people are met.

### 3.6 Involving Communities and Other Stakeholders

During their visit, Inspectors talked to young people, the Headteacher and staff and they were able to find out how well young people are now learning and achieving and how the school is continuing to support them to do their best.

The Parent Council has significantly extended its membership and it is more involved with the school.

Copies of the report have been made available to Elected Members, parents of young people currently in the school and other interested parties.
