

Cabinet – Membership and Allocation of Portfolios

1 Purpose of Report

This report sets out the membership of the Cabinet and invites consideration of the portfolios to be allocated to each of its six elected Members.

2 Membership

On 3 July 2012, the Council, having previously noted the resignation of Councillor Coventry from the Cabinet and the resignations of Councillors Beattie and Bryant from the posts of Leader and Depute Leader of the Council respectively:-

- (a) appointed Councillor Constable as Leader of the Council and noted that in accordance with Standing Order 1.1, the Leader of the Council would be the Convener of the Cabinet;
- (b) appointed Councillor Thompson as Depute Leader of the Council, and noted that in terms of Standing Order 1.1 the Depute Leader of the Council would be the Depute Convener of the Cabinet.

The remaining Cabinet elected Members are Councillors de Vink and. Johnstone (appointed by the Council on 22 May 2012) and Councillors Beattie and Bryant, appointed by the Council on 14 August 2012.

The Cabinet's membership is supplemented by the three statutory religious representatives required under Section 124 of the Local Government (Scotland) Act 1973. These are Mr Paul Hayes; Mr Victor H Bourne; and Mrs M Harkness (appointed by the Council on 26 June 2012).
