External Foster placements currently cost Midlothian Council an excessive amount of money every year. Whilst we regularly review each child in placement through our statutory duties, we do not believe in terminating a placement purely on the grounds of finance. Therefore we have projected					

costings of how much we can save over the coming years if we commit to not placing any child/ren in an external foster placement from here-on in. We have calculated the savings based on the young person remaining in care until the age of 21 thereby meeting our legal obligation and duty under the Children & Young People (Scotland) Act 2014.

Age	By promoting young people to remain in placement until 21 this will offer more opportunities to them post school, thereby giving them security and peace of mind as they transition into adulthood	If the young person chooses not to stay in their foster placement until 21 they can of course return to Midlothian. Experience suggests this often happens when the Young Person is in crisis with no forward planning in place. This can have a detrimental impact upon their future prospects as they transition into adulthood.

The budget reductions shall commence in 17/18 and we shall monitor and review the reduction in placements on a quarterly basis. In addition we shall ensure that our ongoing fostering recruitment campaign continues to meet the need and demands we require, thus increasing the number of our

own Foster Carers within Midlothian.

Placing children and young people out-with Midlothian is not conducive to promoting our ethos where we are committed to care for and educate all children and young people within Midlothian. Whilst there are some success stories of positive external fostering placements, there are equally as many placement break downs which often require us to accommodate young people on an emergency basis and return them to Midlothian with little or no preparation or planning. We know from experience that more often than not most young people return to their family environment post 16 years of age with no real sense of belonging and with nor future planning in place thereby resulting in them transitioning into adulthood with no further education or work prospects. Maintaining and committing to all children and young people being cared for and educated in Midlothian will result in more positive outcomes for all.
