### **1 Purpose of Report**

The purpose of this report is to advise the Cabinet of the appointment of the Rev Ruth Halley as the new Church of Scotland Representative in Education Matters.

Following the resignation of Mr Paul Hayes as the Church of Scotland representative in Education Matters, the Council at its meeting on 11 August endorsed the nomination from the Church of Scotland of Rev Ruth Halley, Minister at Penicuik North Kirk, as their replacement representative.

## **Appointment of the Church of Scotland Representative in Education Matters**

#### **1 Purpose of Report**

On the advent of the resignation of the current Church of Scotland representative (Mr Paul Hayes), the Council is now requested to endorse the nomination from the Church of Scotland for the replacement representative.

#### **2 Background**

##### **2.1 Legislative requirement**

Under the Local Government (Scotland) Act 1973, section 124, the Council is required to have three religious representatives to take an active part in the decision making process in relation to education matters. This largely involves attendance at meetings of the Council and the Cabinet.

##### **2.2 Nomination**

Following the resignation of Mr Paul Hayes, the Council received notification from Ms Agnes Mullen – Principal Assistant to the Church and Society Council in relation to the Church of Scotland's nomination for the vacant representative. She confirmed that the nomination for the new Church of Scotland representative, that had been endorsed by the Church of Scotland Education Committee, was Rev Ruth Halley, Minister at Penicuik North Kirk.

##### **2.3 Code of Conduct and Disqualification**

It should be noted that all Religious Representatives are asked to confirm that they will comply with the general terms of the Councillors' Code of Conduct issued by the Standards Commission for Scotland. They are also asked to confirm that there is nothing in Section 31 of the Local Government (Scotland) Act 1973 (grounds for disqualification), which would prevent them from serving on the Cabinet.
