5. How will you monitor the impact of the changes proposed? When is the budget due to be reviewed?

The mini service review will be carried out during 2018/19 with budget reduction in 2019/20. Figures for positive destinations for school leavers are reported on and published nationally.

6. Please use the space below to detail any other matters arising from the Equality Impact Assessment (EqIA) process.

The majority of young people accessing the services are from more deprived backgrounds and single parent families and will therefore be affected should there be any reduction in provision as a result of the review, although equally they would benefit from any enhancement. As many of the young people receive a training allowance or EMA a reduction in provision will have a financial impact. In addition the services support a high proportion of care experienced young people generally and those returning from residential care in particular.

It is likely through the mini service review that the staffing resource will be reduced overall. At this stage it is difficult to state categorically whether fewer young people will received a service as this will be dependent on the design of the new integrated services. However staff to young people ratios are in place and best practice drives how many young people one adult can work with at one time so a reduction in staff will most likely result in fewer places. The ratio also varies depending on the risk involved with the activity being undertaken, such as during outdoor trips, and the young person's individual needs and behaviours.

A full integrated impact assessment should be carried out of the proposed changes when more detailed proposals are developed, considering the services affected, any disproportionate representation of certain groups within the current users of the services (such as gender reassignment, race, care experienced etc.) and any mitigating factors that could be put in place such as alternative methods of delivery that could enhance the provision or alternative providers or support.
