1. Apologies

- 1.1 It was noted that this was a special meeting of Midlothian Council.
- 1.2 It was noted that no apologies had been received from Elected Members.

2. Order of Business

2.1 The order of business was confirmed as outlined in the agenda that had been circulated.

3.1 The Provost requested that any Elected Member who had to declare an interest in a particular item to do so as the item arose.

4.1 No previous minutes were submitted for approval to this special meeting of the Council.

Outline of report and summary of discussion

The Council heard from the Head of Finance and Integrated Service Support who presented the report which provided the Council with a further update on the Financial Strategy 2016/17 to 2020/21 and which would allow the Council to determine its 2016/17 budget.

Councillor Parry commented that the budget proposals represented a sensible approach given the financial challenges facing Local Authorities. Further Councillor Parry moved that the recommendations contained within the report were accepted with the following amendments:

- Accept recommendations (a) and (b);
- Accept recommendation (c) subject to the following:
 - Item 7 of the proposals Members Environmental Projects reinstate £180,000 per annum back into the General Services Capital Plan;
 - Item 13 of the proposals School meals charges increase delete this recommendation;
- Accept recommendation (d) subject to the amendment to the proposals as moved; and

 Accept recommendation (e) subject to the amendment to the proposals as moved.

Councillor Johnstone seconded Councillor Parry's motion.

Councillor Milligan moved that the Council should take a more cautious approach to the recommended savings package citing that the level of reserves that the Council has built up are in excess of the level of reserves recommended by Audit Scotland. Further, Councillor Milligan recommended utilising these reserves to alleviate the budget pressures would still leave the reserves in a favourable position. Councillor Milligan further raised concerns in respect of the proposal to cut the number of Police Officers in Midlothian; the further pressures that would result as a consequence of the proposals to cut the Devolved School Management budgets; the potential impact on the poorest communities as result of charging for bulky uplifts; and the potential impact of cutting the winter maintenance budget. Following this Councillor Milligan circulated the Labour Group's budget proposal which amounted to utilising further reserves and leaving £11.98m in the reserve. Further Councillor Milligan moved that this should be accepted by the Council.

Councillor Muirhead seconded Councillor Milligan's proposals. Councillor Muirhead was heard airing his concerns in relation to cutting education funding and the potential impact to the quality of teaching. Further Councillor Muirhead cited the potential impact to communities should the proposals to reduce the Community Action Team be approved.

The Council then heard from Councillor Baxter after expressing his views in relation to the proposals moved a single amendment to the Administration's budget to remove Item 4 from the proposals (the removal of the Community Action Team) and to fund this from reserves pending further investigation.

No Councillor seconded Councillor Baxter's motion and therefore it failed.

There followed a lengthy and at times heated debate in relation to the proposals and the impact of these.

At the end of the debate, the Provost requested that Councillors Parry and Milligan summed up their motions and following this asked the Chamber to vote in respect of the motions.

- 8 Members voted in favour of the Labour Group amendment to the budget proposals and 9 Members voted against it.
- 9 Members voted in favour of the Administration recommendations and no Members voted against it.

Decision

Therefore Council agreed to:-

- a) Approve the allocation of £37.086 million to the Midlothian Integrated Joint Board for 2016/17 in respect of delegated services;
- b) Note the additional operational savings summarised in appendix 1;

- c) Approve the savings proposals as set out in appendix 2 and 3 with the exception of the proposal to increase school meal charges and amending the proposal in respect of the Members Environmental Projects to reinstate £180,000 per annum back into the General Services Capital Plan;
- d) Approve the utilisation of £2.668 million of reserves in 2016/17 to balance the budget; and
- e) Subject to the changes which were required in respect of item (c) approve the 2016/17 service budget analysis as set out in appendix 4.

Outline of report and summary of discussion

The Head of Finance and Integrated Service support spoke to the report dated 1 March 2016 which provided the Council a further update on the work undertaken in relation to financial assurance in respect of the delegation of resources to the Midlothian Integration Joint Board from 1 April 2016.

Councillor Johnstone proposed that the recommendations contained within the report were accepted and commented that there were opportunities to be harnessed as a result of the Integration Joint Board in spite of the financial challenges.

- b) Note the ongoing work in relation to the finalisation of the delegated budgets, the issuing of formal propositions to the Board, the issuing of directions by the Board and the consideration of risk sharing arrangements between IJBs.
- c) Note that the Adult and Social Care budget which it is proposed be delegated to the Board amounts to £37.086m and is being considered as part of the latest Financial Strategy report.
- d) Receive a further update in June 2016.
