Purpose of Report

The purpose of this report is to provide an update to Cabinet on the Education Convener Advisory Group. As outlined to Cabinet on both 16 April and 27 August 2013, this forum was to be used informally as a platform for the Education Convener to help inform and explore developments in relevant policy.

This report provides a short summary on progress made and forward planning in relation to this group.

2 Background

The Group has been formed to provide ongoing recognition of, and dialogue with, key stakeholders in education for Midlothian. Parties identified for inclusion are young people, parents and staff. Key principles of operating include working together in an open forum, members offering their views, and encouraging a collective and inclusive process relating to key education policy issues.

3 Progress report

The Group's membership was determined by the Group Convener and the Head of Education and an initial meeting was held. Key stakeholders - pupils, teachers, religious representation and council officers participated in the initial meeting.

In the interim, a new Cabinet holder has since been appointed for Education and has revisited the purpose and constitution of this group. As such, the follow up meeting, arranged for January 2014, was postponed until further notice. Members have been advised accordingly.

It is now the intention of the incoming Cabinet Member to form an Education Committee in place of the Education Convener Advisory Group. The necessary scoping to determine the nature and function of this Committee is underway and the recommended purpose, membership and terms of reference will be brought to Midlothian Council in March 2014.
