Aims and Objectives

Currently residents are given the first bulky uplift each year free of charge. Subsequent uplifts are charged at £20. The intention is to charge for all bulky uplifts at a minimum charge of £20. This would ensure the service more closely reflects the cost of service provision.

The budget saving is put forward to meet the Council's overall budget deficit. The option is to charge for service provision where the costs are met by the income.
