Street Sweeping Review

Report by Ricky Moffat, Head of Commercial Operations

1 Purpose of Report

To provide the Council with an update relating to specific service areas within waste services as follows:-

- Street sweeping
- Litter/dog fouling bins

2 Background

2.1 Performance Review and Scrutiny Committee

At its meeting on 8 October 2013 the Special Performance Review and Scrutiny Committee requested Waste Management Services to present a review of Street Cleansing in early 2014, the intention of which was to identify improvements that could be made to the service. The purpose of the review was to have a close look at the existing allocation of resources to ascertain whether there were more effective work patterns and/or better use could be made of the available vehicles and manpower.

2.2 Current Street Sweeping

Midlothian Council Waste Management Services operates to the Code of Practice on Litter and Refuse (2006) which was issued under section 89 of the Environmental Protection Act 1990 and is available via its attended link:

http://www.scotland.gov.uk/Publications/2006/12/13125718/0.

The objective of the Code of Practice is to provide practical guidance on the discharge of the duties under section 89 of the Environmental Protection Act 1990 by establishing reasonable and generally acceptable standards of cleanliness which those under the duty should be capable of meeting.

The Code of Practice provides a cleanliness standard based on land use and time which duty bodies should comply with when discharging their duties. It sets out grades of cleanliness and divides land into zones according to usage and volume of traffic. If the cleanliness of an area falls, the code sets out a response time, which is the target for the duty body to restore the land to a particular grade of cleanliness. What matters is maintaining the cleanliness of an area, rather than how often it is cleaned.

2.3 Presently Street Sweeping has 32 staff posts on its budgeted establishment. Of the current establishment the position as at February 2014 is as follows:

In addition to carrying out street sweeping duties staff are allocated to refuse/recycling collection routes as and when necessary eg sickness absence cover.

2.4 Dalkeith, Woodburn and Bonnyrigg have dedicated resources each day (man and barrow) where litter is picked up and bins are emptied.

There are 3 SSVs (small sweeping vehicles) with crew cabs, 3 drivers and 3 men crews which attend to shop front areas and tackle specific locations where a need for a litter pick has been highlighted.

Two large mechanical sweepers with a driver clean major routes throughout Midlothian and four small mechanical sweepers with driver clean towns/villages when required.

Dog waste is uplifted by one staff member on a Monday, Tuesday, Thursday and Friday equivalent to twice weekly uplifts and the remaining staff are dedicated to cleaning streets/town centre with the pressure washing machine or assist with bin delivery's.

A list of all litter and dog fouling bins is attached (Appendix 1).

2.3 Current Fleet Assets

Waste Management Services have the following fleet items to deliver the Councils street sweeping service they are:-

- 2 x large mechanical road sweepers.
- 4 x Small/Compact road/footway sweepers
- 3 x Crew cabs.(SSV,s)
- 1 x 4*4 Pick-up (Dog Bins/Domestic waste collection)
- 1 x Van with Whale Power Wash
- 1 x Pick up

3.0 Changes Proposed to Street Cleansing

3.1 High Density Housing

It is known through participation in the Local Environmental Audit and Management System (LEAMS) inspections that kerbside collection of dry recycled materials produces more street litter than that of domestic waste collections.

The dry recycling routes are predominantly operated with four daily collection routes which divide the Council area into bi-weekly areas. It is proposed to mirror these established routes with four compact sweeping machines manned with a driver and a sweeper/labourer. This would allow an increase of physical sweeping within these areas to bi-weekly moving from the current position of four/six weekly litter picking/sweeping.

3.2 Lower Density Housing

It is proposed that lower density housing areas such as villages would be cleansed by one mobile street cleansing team (SSV) consisting of a driver and one sweeper/labourer again it would be proposed that this vehicle would mirror the dry recyclate collection route hence a biweekly cleansing service.

3.3 Town Centres

It is proposed that town centres i.e. Dalkeith, Bonnyrigg and Penicuik have new schedules re-established to allow these areas to be maintained over a wider area. Dalkeith and Bonnyrigg will have two dedicated staff and Penicuik one staff member. Additionally and where necessary staff and a vehicle will be deployed to assist within towns. The vehicle and driver are also rostered to uplift bagged sweeping material.

3.4 Small Shopping Areas

It is proposed that small shopping areas outwith town centres would be cleansed by a mobile street cleansing team (SSV) consisting of a driver and one street sweeper/labourer. Most of these shops would be programmed for daily cleansing but may be part week following inspections.

3.5 All Other Areas

It is proposed that these areas are litter picked/swept by a mobile street cleansing team (SSV) consisting of a driver and two street sweeper / labours, this service will be more reactive than that working to a preplanned route due to the nature of the proposed area to be covered i.e. working to the Code of Practice on Litter and Refuse.

This element of the service would be backed up by the use of two large mechanical sweeping machines often working in conjunction with each other to allow major routes and unclassified roads to be cleansed. In addition, they will be closer aligned to gully cleansing operations carried out by Road Services.

3.6 Litter/Dog Bin Collection Service

It is proposed to increase the number of bins within Midlothian but to provide this the service would require the introduction of an additional collection vehicle. This is in addition to providing a refuse collection service to the small number of non- accessible rural households. The two operatives would be responsible for installing, maintaining and cleaning of all bins.

3.7 Street Washing/Chewing Gum Removal

It is proposed to continue to deploy the street washing vehicle consisting of a driver on the current schedule of work.

3.8 Depot Attendant/Vehicle Washer

It is proposed to maintain the current deployment of one employee within this role.

4.0 Litter/Dog Bins

There are a total of 203 litter bins and 188 dog fouling bins throughout Midlothian. The location of these bins has largely been due to historical reasons rather than a specific policy. All dog bins are generally emptied on a twice weekly basis with litter bins emptied on a weekly basis. Those within town centres and shopping areas are emptied more frequently if required.

4.1 Dog Fouling

In October 2003 a change of legislation to the Dog Fouling Act (Scotland) 2003) made it an offence for a person if charge of a dog and failing to clear up after it. (Fails to remove and dispose of the excrement). A Person suspected of committing an offence could be issued with Fixed Penalty Notice.

Crucially the Scottish Government provided no additional revenue to implement changes to the legislation. Councils were left to either increase the number of dog bins or provide enforcement staff from within existing resources.

Fixed penalty notices are currently issued by colleagues within Environment Health.

5.0 Policy for the Placement of Litter/Dog Bins

It is acknowledged that litter and dog bins have been placed for a variety of reasons over a long period of time. It is proposed that a

criteria for the consideration and placement of bins is adopted (see 6.0). The purpose of this criteria is to state clearly the rationale that will apply in relation to applications for new bins.

However, it also the intention that all existing bins are assessed over a period of six months and careful consideration given as to whether these bins are removed or re-sited in line with the agreed criteria.

Before a bin is removed consultation will be undertaken with the three ward members for a particular area.

5.1 Policy Framework

5.1.1 Following a review of the current resources utilized to service these bins it has been ascertained that a further 300 bins can be placed if an additional vehicle is provided. All new bins will be dual litter/dog fouling bins where practical. This additional resource to service bins will also allow for increased frequency of collection for existing bins.

Where it is deemed necessary or practical to place a dog fouling bin only these will normally be provided at the following locations:-

- Entrances to parks and recreation grounds.
- Access points to Designated combined cycle/walkways.
- Entrances to fields and wooded areas that are popular dog walking sites
- Dog mess hotspots as determined by site visit or complaints received.
- **5.1.2** The Council will provide, maintain, empty and cleanse dog fouling and litter bins throughout the Council area at the required frequency to help in the discharge of its duties as a principal litter authority.

This objective will be met by:-

- Providing bins both post mounted and free standing which meet the needs of the local community, whilst causing the minimum impact on the surrounding environment. (Refer to criteria for the placing of bins at 6.0)
- Maintaining bins to a standard by which they are fit for purpose and in themselves are not detrimental to the environment and replace damaged /stolen bins within 20 working days.
- Empty bins on such a frequency as necessary to prevent them from becoming a nuisance or giving reasonable grounds for complaint, minimum weekly/maximum daily.
- Cleansing bins on such a frequency as necessary to prevent them from becoming a nuisance or giving reasonable grounds for complaint, minimum twice a year.
- Making information available regarding the location and emptying schedule of all litter and dog bins for which it is responsible (to be available on the website).
- **5.1.3** Where the Council is required to replace or agrees to install new dog fouling and litter bins, regard will be given to the sighting to ensure that the bins are of practical use to all. Under normal circumstances all bins

- will be placed at a point no greater than 20 meters to the nearest vehicle access point.
- **5.1.4** The Council will monitor the usage of all dog fouling and litter bins and utilise monitoring data to determine the ongoing viability regarding the location of each bin and its capacity.

6.0 Criteria for the Placing of Bins

- 6.1 Requests for additional bins may be submitted by residents, Community Councils, Councillors. MP's, MSP's, Council officers, or other interested parties. An assessment will be carried out based on the criteria listed below and a decision made and advised to the person(s) making the request within 20 working days.
- **6.2** Each request or requirement for a new bin should be assessed using the scoring system below.

7 Report Implications

7.1 Resource

The cost of purchasing the additional 300 bins is £0.060 million. This will require to be added to the General Services Capital Plan in 2014/15. Provision is already included for the replacement vehicle.

Approval of funding for the bins will reduce the maximum unallocated funding resources available for 2014/15 within the plan to £2.200 million.

7.2 Risk

There are no direct risks highlighted as a result of this report. However introduction of the aforementioned changes will reduce incidences of litter and dog waste fouling.
