

Inspection of Mount Esk Nursery School

Report by Mary Smith, Director, Education, Communities and Economy

1 Purpose of Report

This report outlines the outcome of the above inspection as carried out by Education Scotland and Care Inspectorate in October 2013.

2 Background

- 2.1 Mount Esk Nursery School and Nursery Class was inspected in October 2013 as part of a national sample of primary and nursery education. The report was published on 17 December 2013 and has been distributed to all Elected Members and Church Representatives on the Cabinet for their information. The inspection covered key aspects of the work of the school at all stages.
- 2.2 Following the inspection of each school, the Scottish Government gathers evaluations of three important quality indicators to keep track of how well all Scottish schools are doing. Noted below are Education Scotland's evaluations for Mount Esk Nursery School:

Improvements in performance	Very good
Children's experiences	Very good
Meeting learning needs	Very good

The Inspectors also evaluated the following aspects of the work of the nursery:

The curriculum	Very good
Improvement through self-evaluation	Very good

The Care Inspectorate also uses grades to ensure inspection activity is targeted and proportionate. The grades at inspection are awarded against four quality themes and the outcomes were as follows:

Quality of care and support	Very good
Quality of Environment	Very good
Quality of Staffing	Very good
Quality of management and leadership	Very good

- 2.3 The following key strengths were indicated by the inspection team:
 - Children who are motivated and enthusiastic learners.
 - The strong partnership with parents and other agencies which is leading to positive outcomes for children and their families.
 - The approaches of staff to meet children's individual learning needs.
 - Effective teamwork demonstrated by all staff and their determination to offer a high quality service.
 - Leadership for learning provided by the Headteacher and her work in ensuring the nursery is a key part of the local community.
- 2.4 The following areas for improvement were agreed with the Education, Communities and Economy Division:
 - Through reflecting on children's learning, continue to build on how staff use self-evaluation to determine the actions they take and the successes they achieve.
 - Continue to take forward the priorities, as described in the nursery improvement plan, to build on the community within the nursery and the work with families and partners.

3 Conclusion

The inspection team have indicated that they are satisfied with the overall quality of provision and are confident that the nursery's self-evaluation processes are leading to improvements. As a result they will make no further visits in connection with this inspection.

4 Report Implications

4.1 Resource

There are no financial and human resource implications associated with this report.

4.2 Risk

Education Scotland and the Care Inspectorate visit a sample of schools and nursery classes every year to find out how they are performing. A report is published which informs parents about the key strengths of the school, its capacity for further improvement and sets out the main points for action.

Monitoring, review and evaluation of progress by the Schools Group Manager and members of the 3-18 Improvement Team is the control measure in place to reduce the risk of failure of the school to demonstrate its capacity to improve.

- 4.7 Ensuring Equalities The Nursery Improvement Plan will be screened for equalities implications.
- 4.8 Supporting Sustainable Development The Nursery Improvement Plan allows for sustainable development and improvement.
- 4.9 IT Issues There are no IT issues arising from this report.
