Consultation on Should the Use of wild animals in travelling circuses be banned in Scotland

Report by Director, Resources

1 Purpose of Report

To review the questionnaire attached to Government consultation about an impending review of the banning of the use of wild animals in travelling circuses in Scotland.

2 Background

In terms of the Civic Government (Scotland) Act 1982, the Council Licences Places of Public Entertainment, including Circuses with Wild Animals. In Midlothian, any such public entertainment licences are granted subject to a full vetinerary inspection of all animals, the cost of which is borne by the licence – holder. A blanket ban was not possible. All applications have to be considered on their merits.

The current policy of the Council, as landowner ie in relation to Parks and Open Spaces, is that any requests from the proprietors of travelling circuses with wild animals will be refused.

On the basis of these policies ie with an emphasis on protection of animal welfare, a draft response to the Questionaire has been prepared and is attached as an Appendix hereto. Members are invited to consider it when deliberating on the subject.

(In England, the Westminster Parliament has passed legislation to ban wild animals in circuses from early 2015.)
