

Community Council Boundary Change

1 Purpose of Report

The purpose of this report is to outline the proposed changes to the boundary between Gorebridge and District and Moorfoot Community Councils and seek formal approval for the change to be made.

2 Background

- 2.1 Gorebridge and District and Moorfoot Community Council contacted Midlothian Councils Communities Team to amend the boundary between their respective Community Councils.
- 2.2 The proposed change would allow the new housing estate at Harvieston and the planned new estate at Redheugh to become part of the Gorebridge Community Council area rather than be part of the Moorfoot area, as is the current situation.
- 2.3 Moorfoot Community Council represents a very rural area whereas Gorebridge and District Community Council is a more urban area. The new housing developments will access facilities in the Gorebridge area and both Community Councils feel that these new developments would be better aligned with Gorebridge and District Community Council rather than Moorfoot Community Council.
- 2.4 A joint meeting was held on 3 May 2016 with representatives from both Community Councils and Midlothian Council's Communities Team and Planning Department. Mutual agreement was reached on the proposed new boundaries.
- 2.5 Both Community Councils unanimously agreed to follow the process to amend the boundary as set out in section 8, Amendment to the Boundaries and Composition of Community Councils, in Midlothian Councils' approved Scheme for Community Councils.
- 2.6 A joint letter from both Community Councils was submitted to Midlothian Council to notify them that Gorebridge and District Community Council and Moorfoot Community Council were in agreement about the proposed changes.
- 2.7 The proposed changes were publicised and a 90 day public consultation was held. No objections were made to the proposed changes.
- 2.8 A final public vote was held by both Gorebridge and District and Moorfoot Community Councils and the proposed changes were unanimously agreed.
