

Taxis and Private Hire Cars and Drivers Extended Term Licences

Report by Director, Resources

1 Purpose of Report

To seek approval to the introduction of licences for extended terms.

2 Background

2.1 Currently, licences for Taxis and Private Hire Cars and Drivers are issued for one year.

The trade generally favour extending the term to three years; and support the introduction of the extension of medical examinations for drivers from age 45 years and every five years thereafter and then annually after the age of 65 years. Currently drivers who suffer from a medical condition that potentially impairs their ability to drive are also referred to the Council's independent medical adviser for examination.

At the meeting of the Hire Car Liaison Group on 13 March 2014, the Trade side expressed a preference for the cost of such examinations being met by the individual drivers concerned.

Fees require to be fixed in consultation with the Short Term Working Group on Fees and Charges.

5 Recommendations

It is recommended that the introduction of three year licences for drivers be approved, subject to further examination of the notion that the individual licence-holders meet the cost of their examinations; and fixing of the Fees by the Council, following consultation with the Short Term Working Group on Fees and Charges.
