1 Order of Business

The Clerk advised that:-

- (i) the "To Follow" report for Agenda Item 9 had been circulated on 9 November 2014 under the amended title of "Gorebridge North and Bilston Primary Schools – Progress Report – Report by Head of Property and Facilities Management" and (ii) the Convener had agreed to accept this as urgent business in view of the Council's interest in the matter (as dealt with under paragraph 1 of the Addendum hereto); and
- (b) Agenda Item 10, namely the "Minutes of Meeting of Midlothian Joint Consultative Group of 1 July 2014," had an education interest and therefore fell to be considered as such under private business (as dealt with under paragraph 2 of the Addendum hereto).

3 Minutes

5 Inspection of Cornbank St James Primary School and Nursery Class

There was submitted report by the Head of Education, outlining the outcome of an inspection carried out by Education Scotland at Cornbank St James Primary School and Nursery Class in October 2014. The evaluations were as follows:-

The Inspectors also evaluated the following aspects of work of the school and nursery class:-

The curriculum	Good

The report set out the key strengths found by the inspection team and areas for improvement which had been agreed with the Education, Communities and Economy Division.

Overall, the inspection team had indicated that they were satisfied with the overall quality of provision and were confident that the school's self-evaluation processes were leading to improvements. As a result, they would be making no further visits in connection with the inspection. However, the Council would inform parents about the school's performance.

6 First Statutory 'Biodiversity Report' on Pursuance of Statutory Duty to Further the Conservation of Biodiversity

There was submitted report, dated 18 December 2014, by the Director, Resources, recalling that the Cabinet, at its meeting on 18 November 2014, had considered a report by the Head of Communities and Economy, seeking approval of the Council's First Statutory Biodiversity Report.

Following consideration, the Cabinet approved the Biodiversity Report and *inter alia* agreed to refer it to the Performance Review and Scrutiny Committee for its interest. The report was thereafter presented to the Performance Review and Scrutiny Committee on 25 November 2014. At that meeting the Committee had expressed concern that there was no officer resource dedicated to biodiversity and accordingly agreed to recommend to Cabinet that it review the staffing resources available to support biodiversity with a view to ensuring that the Council fully met its statutory obligations.

The report advised that the Performance Review and Scrutiny Committee had also agreed to invite the Cabinet Portfolio holder with responsibility for biodiversity to discuss the matter with them at their next meeting on 20 January 2015. Arrangements had therefore been made for Councillor Bryant, the Portfolio-holder, to attend this meeting.

The Cabinet was invited to consider the aforementioned recommendation of the Performance, Review and Scrutiny Committee and to note that Councillor Bryant, Cabinet Portfolio-holder, would be discussing the subject matter with the Committee on 20 January 2015.

Decision

- (a) To note advice from the Head of Communities and Economy that the previous half funded post of biodiversity officer had become vacant in October 2011 and had been deleted from establishment to meet further savings targets around that time;
- (b) To note the intention of the Cabinet Portfolio-holder, Councillor Bryant, to discuss the position further with the Head of Communities and Economy and that he would also be discussing the subject matter with the Performance Review and Scrutiny Committee on 20 January 2015; and
- (c) Pending the aforementioned discussions, to take no action on the recommendation of the Performance Review and Scrutiny Committee at this stage.

7 Midlothian Strategic Housing Investment Plan 2015/16 – 2019/20

There was submitted report, dated 12 December 2014, by the Joint Director, Health and Social Care, appending a copy of the Midlothian Council Strategic Housing Investment Plan (SHIP) 2015/16 – 2019/20.

The report advised that the Scottish Government required local authorities to prepare a SHIP every two years which identified the main investment priorities for affordable housing in their area. The SHIP as presented set out the Council's approach to promoting affordable housing investment and meeting the housing supply targets identified in the Local Housing Strategy.

The SHIP acknowledged that there had been significant achievements in affordable housing investment in Midlothian and pointed out that since 2006, when the Council had began its social housing programme of developing new council housing, a total of 1,368 new affordable homes had been developed. Key achievements in 2013/14 were also highlighted.

Despite the considerable level of investment which had taken place, the SHIP nevertheless identified a requirement to increase the supply of affordable housing in all areas of Midlothian to meet a growing number of households that had a housing need. In addition, it was pointed out that property in the private rented sector and owner occupied tenures would not be affordable as a housing option for a significant number of households in Midlothian.

To address this demand the SHIP identified and prioritised sites in Midlothian for future investment in developing new affordable rented housing. The total level of new supply by 2019/20 was estimated to be 672 units, with the following breakdown of tenures:-

- 322 units Council housing.
- 260 units RSL social rented housing.
- 90 units For RSL mid-market rent.
- Additional 2 units to be rented as social housing (To be purchased on the open market for re-housing Newbyres Crescent residents.)

The report also provided information on the highest levels of subsidy available to both the Council and RSLs, which had been increased by £16,000 per unit in July 2013 to support affordable housing providers in undertaking an increased level of development.

Decision

- (a) To note the content of the report;
- (b) To agree that the Strategic Housing Investment Plan 2015/16 2019/20 be submitted to the Scottish Government; and
- (c) To commend the officials for the work they had undertaken in preparing the Plan.

 - Subject to tenders being returned within the parameters set out in the report, to ask the Director, Resources to contract with the successful bidding contractor following completion of the tender period; and
 - To congratulate the officials for the work which they had undertaken in bringing forward the plans.
