The aim is to reduce costs by closing the public toilets in Dalkeith, Loanhead, Penicuik, Bonnyrigg and Gorebridge. This saves on servicing costs and increased maintenance, due to vandalism, as well as closing access to those who continue to misuse the premises. Alternative service delivery options including self cleaning automated toilets which are charged may be introduced.

Across Scotland there were five authorities who have reduced their school crossing service, primarily in rural areas (although this requires to be updated).

Approximately Four years ago the Council removed school crossing guides during the lunchtime period. This was due to the fact that no children were in fact leaving the school during this period (with two exceptions). There have been no significant issues raised as a consequence of this change.

One option is to have controlled crossings placed where guides (without a crossing) were to be removed. However this has revenue and capital budget implications.
