Children and Young People Bill - Early Learning and Childcare additional costs: allocation and distribution

The Scottish Government has made a commitment to local government that it will fully fund the agreed additional costs arising from the Children and Young People Bill to local authorities, including the costs of implementing the early learning and childcare provisions. The Budget announcement in September 2013 confirmed that an additional £186 million over the next two years will be made available to local authorities to meet the implementation costs of early learning and childcare (including early learning and childcare for 2 year olds who are looked after or under a kinship care order). This includes £50.8 million revenue and £30 million capital in 2014–15; and, £75.1 million revenue and £30 million capital in 2015–16.

The distribution methodology to be used for the capital and revenue costs of the early learning and childcare provisions for 2014-15 and 2015-16 have been agreed by the Scottish Government and COSLA Council leaders. The allocations use the amounts announced in the draft budget.

Annex A includes the subsequent allocations for revenue and capital for 2014-15. The allocations for 2015-16 will follow.

These allocations will be added to the relevant year's General Revenue and General Capital Grant figures and paid from 1 April 2014 as part of the block revenue and capital payments. The revenue figures are paid every Wednesday with the capital payments made on or as near as possible to the 15th of each month.

We will continue to work closely with COSLA and local authorities, along with other key stakeholders, to support implementation of the legislative proposals.


