Appointment of Joint Director, Health and Social Care

Report by Kenneth Lawrie, Chief Executive

1 Purpose of Report

The purpose of this report is to confirm the intention of Eibhlin McHugh to retire from her role as Joint Director, Health and Social Care and as a result of this to agree to the recruitment process for the position of Joint Director, Health and Social Care.

2 Background

The Chief Executive has confirmed that Eibhlin McHugh has written to him to confirm her intention to retire from the position of Joint Director, Health and Social Care at the end of October 2017.

Under the requirements of the Standing Order 17 of the Council's Scheme of Governance, the appointment of Chief Officials (including the Joint Director, Health and Social Care) will be by the Council on a recommendation by the Cabinet which will also recommend conditions to apply to the posts.

This report sets out the recruitment plan for the position of Joint Director, Health and Social Care (appendix 1) and further seeks agreement from the Cabinet to proceed on this basis.

Cabinet should note that a Special Meeting of the Midlothian Integration Joint Board has also been convened on 12 July 2017 at 2pm to approve the recruitment of a Chief Officer of the Midlothian Integration Joint Board (a position which Eibhlin McHugh currently holds and will retire from at the point she retires from her position of Joint Director, Health and Social Care).

One of the aims of the recruitment plan for the Joint Director, Health and Social Care is to follow a similar arrangement as currently exists whereby the Joint Director, Health and Social Care will also assume the role of Chief Officer of the Midlothian Integration Joint Board.

Accordingly, in order to comply with Standing Order 17, it should be noted that it is proposed in the recruitment plan that Midlothian Council Cabinet will be represented on the interview panel by Councillors Milligan and Muirhead. Following the Candidate presentation and interviews, Councillors Milligan and Muirhead will report back to Cabinet on the process which has been followed and Cabinet will then be asked to approve a recommendation to the Council.
