

No 328 Bus Service

1 Purpose of Report

To present a petition from residents of Danderhall, Millerhill, Newton Village and others calling upon the Council to reinstate the No. 328 Bus Service, which previously served these communities.

2 Background

On 22 April 2014, the Cabinet agreed, having been advised that the operator of the 328 Bus Route (Edinburgh Coach Lines Ltd) had decided to cease operation on commercial grounds, to replace the service with a Ring & Go Service. The ring and go service came into operation on 21 April 2014.

3 Petition

3.1 The attached petition **(Annex 1)** has been received from Mrs Mary Murray, 23 Edmonstone Road, Danderhall.

4 Petitions – Rules and Procedures

- **4.1** The adopted Midlothian procedures identify 11 categories for which petitions cannot be entertained. The submitted petition is not proscribed by any of these categories and is therefore valid.
- 4.2 The petition is in the following terms,viz:-

"We want Council to re-instate a bus service. The withdrawal of the 328 Service has left many elderly and disabled residents housebound."

4.3 The petition itself contains a total of 1287 signatures. A copy of this has been placed in the Members Library. The petition is supported by a questionnaire issued by Danderhall and District Community Council "On the impact and effects on our elderly and infirm due to the withdrawal of all local bus services". A copy of the questionnaire is appended to the Petition document and copies of completed questionnaires have also been placed in the Members' Library.
